Mayor Smart asked Richard Davis to open the meeting in prayer; Pam Chanler led the Pledge of Allegiance.

Richard Davis motioned to adopt Resolution No. 04-2026 requesting assistance from the Webster Parish Police Jury with the purchase of sand clay gravel. Wayne Bolton seconded. Motion carried.

Keith Merritt motioned to adopt Resolution No. 05-2026, Town of Sibley Travel Policy. Wayne Bolton seconded. Motion carried.

Assistant Fire Chief Richard Davis gave the April 2026 Activity Report for the Sibley Volunteer Fire Department.

Assistant Police Chief Clint Meshell gave the April 2026 Activity Report for the Sibley Police Department.

The Board acknowledged receipt of the April 2026 Financial Report.

The mayor gave updates that included the Playground Project, Water Plant Project, Water Tank Rehab, and the Police Department Taurus Auction.
